117 Public Participation

Since nobody had given the requisite notice to the Clerk to enable them to address the meeting, no public participation took place.

118 Minutes of Meetings

Unlike the procedure normally adopted whereby the Mayor immediately endorses the minutes, it was agreed that the Clerk should sign the minutes on her behalf.

119 Matters Arising

There were no matters arising.

120 Budget 2021 / 2022

The Clerk presented the proposals for the 2021 / 2022 budget and precept.

The Clerk also informed Councillors of the following:

- a) At this point in time, Towns and Parishes did not have to work under the same Government constraints that Districts and Counties were bound by i.e. a restricted rise in Council Tax charges.
- b) Towns and Parishes could, in the future, be requested to undertake more additional functions that Districts and Counties currently undertook but may decide to cut back due to budget constraints.
- c) The budget presented took account of the economic climate and likely changes to future precept rules. It had been set to maintain the services and support currently provided whilst ensuring adequate reserves.
- d) Due to the possibility of the FDC tax-base estimate changing, it would be necessary to approve the budget and precept in principle at this meeting and then ratify or amend the figures accordingly at the 4th January 2021 meeting.

In particular, the Clerk highlighted the following points within the budget:

- a) Maintaining relatively high contingencies due to the unpredictable nature of local politics in possibly having to provide unexpected support.
- b) Continued support for the town's CCTV.
- c) Continued support for March Town FC Estover CIC (previously known as Estover Playing Field 2015 CIC).
- d) Continued support for March Museum and March Street Pride.

Following discussions, it was unanimously agreed that the budget and precept be accepted without amendment (Proposer Councillor J French, Seconder Councillor Jack).

The figures accepted equated to a budget of £292,120 and a precept requirement of £320,000. It was agreed that these figures would be ratified (following amendment if necessary) at the 4th January 2021 meeting.

Full details relating to the budget and precept will be included as an appendix to the 4th January 2021 minutes, at which time all outstanding items will have been finalised.

121 Remembrance Day Events 2021

The Mayor, Councillor Kim French, advised Councillors that new rules brought in by the Royal British Legion Headquarters meant that local branches of the Royal British Legion were no longer allowed to organise the arrangements (including road closures) necessary for future successful Remembrance Day Events.

To overcome these problems, it was suggested that March Town Council should employ Lt Col Nigel Spencer MBE as Remembrance Events Organiser and Mark Wilding as Deputy Remembrance Events Organiser. Neither post would carry a salary but essential out-of-pocket expenses would be reimbursed.

Following discussions, it was unanimously agreed (Proposer Councillor Connor, Seconder Councillor Purser) that both posts should commence from 1st January 2021 and that the Town Clerk should notify them accordingly.

Both posts would be directly answerable to the Mayor and Town Clerk.

It was also agreed that a bottle of port should be gifted to both Messrs. Spencer and Wilding

in recognition of their past efforts.

The Town Clerk would arrange the purchase of the above two bottles, which would then be passed on to Councillor Jack for handover.

122 Museum Lease Extension

The Clerk reported that the Council's lease with the Museum would expire in 2023 if allowed to run its full course.

He suggested, therefore, that a 21 years extension should be granted at the earliest opportunity. This would ensure that the Museum could plan ahead in the knowledge that their tenancy was secure for the foreseeable future.

The previous 21 years extension was granted in 2002 and, at that time, it was suggested that extensions should be provided when the time remaining dropped to 7 years. We have, obviously, now passed that point so urgent consideration should be given to the request. Following discussions, it was unanimously agreed (Proposer Councillor Purser, Seconder Councillor Jack) to support the extension and the Clerk was instructed to make the necessary legal arrangements to facilitate this.

123 Cambridgeshire County Council Update

The Clerk reported that all email updates are being circulated on a daily basis. Councillors J French and Gowing then reported as follows:

- a) Work on the pedestrian crossing in St Peters Road has now been completed.
- b) A pedestrian crossing will also be installed in Station Road in January 2021.
- c) A speed limit is being introduced in Upwell Road.
- d) Investigations are taking place with a view to renovating the Further Education Centre in Station Road.
- e) Assets owned by This Land Limited within March are being marketed in the manner deemed most appropriate for each site.
- f) A Committee has been established to investigate carbon reduction matters and protocols.
